### SANTA CRUZ COUNTY FAIR CONTRACT REGULATIONS

#### IT IS UNDERSTOOD THAT:

- A. Rental fee must accompany signed contract. Space is available on a first come first served basis. No refunds on space cancellations after September 1, 2010 NO EXCEPTIONS!
- B. Certificate of insurance is required even though the signature on contract agrees to release and save SCCFRA harmless from any liability due from and not limited to accidents & injuries suffered by the exhibitors, his agents, employees &/OR PATRONS VISITING THE PREMISES DURING THE OCCUPANCY OF THE PREMISES BY THE EXHIBITOR.
- C. There will be no subleasing without written approval of the SCCFRA.
- D. Merchandise to be shown and sold must be listed on the reverse side of application for approval by SCCFRA. Toys which require water or liquid in any form will not be permitted, nor will any cap type toys or silly string be allowed.
- E. All displays and decorations must be flameproof. Amplifications and sound must be kept to a minimum.
- F. Reliable security will be maintained at all times from Friday morning through Sunday evening. However, SCCFRA will not be responsible for any theft, pilferage or acts of vandalism.
- G. Booth set up must be completed by 5 p.m. on Thursday and must remain setup until 5:00 p.m. on Sunday. Vehicles are not allowed in grounds during the fair except to restock booths from 7:00 a.m. – 8:30 a.m. Vehicles will be allowed in for takedown Sunday after 5:00 p.m. on a limited basis (depending on crowd size) or booths may be taken down on Monday. Absolutely no early breakdowns without office approval.
- H. All food concessions must have a Santa Cruz County Health Permit.
- I. This contract is subject to the approval of the SCCFRA, we reserve the right to cancel this contract at any time without cause.
